4. ALL SUBMISSIONS must include information about the product (these can be selected from existing details as appropriate):

 - i. Maximum truss spacing
 - ii. Minimum underlayment thickness, type, etc.
 - iii. Subfloor – gap spacing, T&G,
 - iv. Surface preparation, etc.
 - d. **Materials: for example...**
 - i. Mortar type – ANSI spec.#, etc.
 - ii. Grout type – ANSI spec.#, etc.
 - iii. Membrane system – ANSI spec.#, etc.
 - e. **Preparation by Other Trades: for example...**
 - i. Treatment of board joints and fastening schedule
 - ii. Subfloor preparation
 - iii. Subfloor variation limitations
 - f. **Movement Joint requirements**
 - g. **Installation Specifications: for example...**
 - i. Tile – per ANSI A108.XX
 - ii. Grout – per ANSI A108.YY
 - iii. Membrane – per manufacturer’s instructions, etc.
